I. Audience

This document is intended for business, technical and EDI personnel engaged in electronic connection with INTTRA for the purpose of receiving an application error and acknowledgment XML VGM RESPONSE in response to a submitted EDI XML VGM transaction.

The following sections provide information regarding General Conventions, Message Flow, and Message Specifications. Additional reference guides for purposes of establishing Internet based file exchange are also identified.

II. Business Process Rules

XML VGM RESPONSE transactions are generated and sent for each XML VGM transaction received.

1. INTTRA receives the VGM transaction performs business logic and sends a XML VGM RESPONSE.
2. INTTRA sends a XML VGM RESPONSE transaction when a CONTRL transaction is received from the Carrier/Terminal in response to receiving a VERMAS transaction.
3. INTTRA sends a XML VGM RESPONSE transaction when an APERAK is received from the Carrier/Terminal in response to a VERMAS transaction.


III. General Conventions

IV. Implementation

Version 1.0 of the INTTRA XML VGM RESPONSE Message represents the EDI transaction format by which INTTRA sends errors and acknowledgments whether or not the submitted VGM transaction was successfully processed by INTTRA and Carrier/Terminal's system.

All examples of Segment data are provided as guides only and not to be taken literally.

V. Message Flow



- A. INTTRA receives an XML VGM transaction from a Submitter, and creates and sends a VERMAS transaction to the Carrier/Terminal.
- B. INTTRA sends an XML VGM RESPONSE to the Submitter for the XML VGM transaction reporting acceptance or rejection by INTTRA.
- C. INTTRA sends a VERMAS transaction to the Carrier/Terminal (if XML VGM transaction was accepted).
- D. INTTRA receives a CONTRL transaction from the Carrier/Terminal in response to the VERMAS transaction.
- E. INTTRA sends an XML VGM RESPONSE to the Submitter for the VERMAS transaction acknowledged by the Carrier/Terminal (receipt of a CONTRL transaction from the carrier/terminal).
- F. INTTRA receives an APERAK from the Carrier/Terminal indicating acceptance or rejection of the VERMAS transaction by the Carrier/Terminal.
- G. INTTRA sends an XML VGM RESPONSE to the Submitter for the APERAK received from the Carrier/Terminal reporting acceptance or rejection of the VERMAS transaction by the Carrier/Terminal.

Carrier/Terminal may send CONTRL, only APERAK, only or both transactions. XML VGM RESPONSES will be sent to submitter accordingly. So submitter may only receive (F) Acknowledgment XML VGM RESPONSE or (H) Acceptance or Rejection XML VGM RESPONSE or both.
